## **APPLICATION FOR EARLY RELEASE OF IMPOUNDED VEHICLE**

# Eligibility criteria and instructions

Only vehicle impoundments of **30 or 60 days** are eligible for consideration of early release. This does not include vehicle impoundments of 45 days as a result of charges under Section 345(3) of the *Motor Vehicle Act*.

### Who can apply?

- The owner of the vehicle provided they were not the driver of the vehicle at the time of impoundment.
- A person authorized by the owner.

An applicant other than the owner must have the owner's authorization.

The applicant must hold a valid driver's licence and not be prohibited from driving.

#### Instructions for completing form

- Complete the form below and choose the grounds for application that apply to your situation.
- Provide details regarding your choice.
- · Sign and date the form.
- If you are not the owner of the impounded vehicle, you must have the owner sign the form authorizing your application for early release.

NOTE: You must apply within 15 days of the vehicle being impounded.

#### Appeal fee

The application fee of \$64 plus HST must be paid before the application can be reviewed. Payment may be received at any Service New Brunswick office throughout the province and the completed application and proof of pay-ment can be forwarded to the Motor Vehicle Branch via fax to 506-462-2130.

Any questions regarding this form can be directed to the Department of Public Safety, Motor Vehicle Branch at 506-453-2410.

You will be advised in writing of the Registrar's decision regarding your application. If satisfied with the application and that grounds have been established, the Registrar *may* order the early release of the impounded vehicle and if so, you will be provided with documentation to present at the impound facility.

The vehicle will only be released upon payment of all fees owed to the facility in relation to removal and impoundment of the vehicle.
