A)	Gross Proceeds/Receipts	Total dollar value from Sale of all Bingo paper, (books, specials, bonanza, earlybirds, winner takes all (WTA)), as well as any monies raised from the sale of dabbers, tape or other bingo supplies. Please Note: Raffle tickets and/or break-open tickets sold at bingo events must be licensed and earnings reported separately.

5.	Equipment Rental	Total amount of money paid for the rental of equipment during this reporting period.

7.	Advertising	Total cost of advertising in newspapers, posters, banners, radio and TV during the reporting period.
