Express Entry Labour Market Stream New Brunswick Provincial Nominee Program



Unless you are currently authorized to work in Canada and have a valid job offer from an employer in New Brunswick, you must show that you have enough money to support yourself and your family after you get to New Brunswick.

You must declare all assets and liabilities that belong to you and your spouse or common-law partner in your current place of residence and overseas. You must include financial statements and other relevant documents to support the information provided. You cannot borrow this money from another person. You must be able to use this money to pay the costs of living for your family (even if they are not coming with you).

You will need to show proof of unencumbered and readily transferable funds in a convertible currency available for settlement in New Brunswick in the form of a current bank certification letter, evidence of savings balance along with a six month history of banking transactions, and/or current fixed or time deposit statements.
