

## CAMP LOT LEASE APPLICATION PACKAGE

A camp lot lease is a legal agreement which authorizes the use of Crown Land for the purpose of establishing and maintaining a recreational camp lot. Leases are issued for a term of 10 years.

The leased area is approximately 0.4 hectare (1 acre) on which one permanently affixed camp can be placed, for seasonal or part time use. It cannot be used as a principal residence. An affixed camp must be built within the first 2 years.

A camp is a built structure that:

- provides temporary accommodation
- is affixed to a leased camp lot via in-ground or above-ground support structure (e.g. blocks, foundation)
- may be placed or constructed on the lot and may include a modular or prefabricated camp that is transported to the leased lot
- does not include garages, baby barns, sheds, recreational or other vehicles, shipping containers, RVs and travel trailers, regardless of whether the wheels are attached.

### APPLICATION FEE

\$575.00 non-refundable (\$500.00 plus \$75.00 HST).

\*Fees are established in accordance with the *Lands Administration Regulation - Crown Lands and Forests Act* and are subject to change.

### PROCESS

Your application will be reviewed by the Crown Lands Branch. Applicants must have no outstanding accounts with the Department of Natural Resources and Energy Development (DNRED) (e.g. rent, property taxes, etc.). The review process is expected to take between 4 and 8 weeks.

**Permits and Authorizations:** Compliance is required with all laws whether rural community, municipal, provincial or federal, and may include obtaining all required permits and authorizations such as: building permit, harvesting permit, quarry permit, and petroleum storage licence.

## IF YOUR APPLICATION IS APPROVED

Once your application is evaluated and approved, a letter from the DNRED will inform you of other requirements which may include the following:

**Plan of Survey**: If the site has not been surveyed, the applicant must hire, at their own expense, a registered New Brunswick Land Surveyor. The plan of survey must be submitted to DNRED for approval.

### **Requirements upon issuance of the lease:**

**Annual Rent**: Rents are invoiced annually on April 1, established in accordance with the Lands Administration Regulation, *Crown Lands and Forests Act* and are subject to change.

For example, rent for a 0.4 ha upland camp lot is \$320.00 and \$640.00 for a 0.4 ha waterfront lot.

**Other terms and conditions may apply.**
