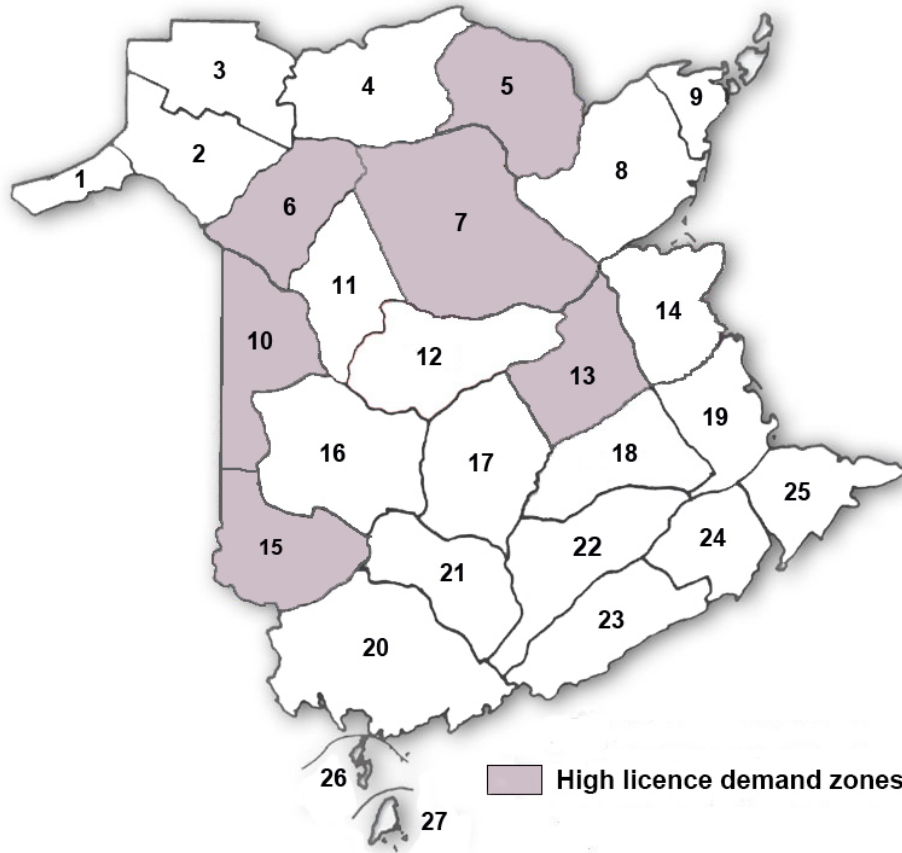

**Attention:** (1) Non-resident black bear licence allocations are issued by DNRED for Wildlife Management Zones 1 to 25. Licences may not be available or are very limited in “high licence demand zones” which include zones 5,6,7,10,13, and 15. (2) New applicants are limited to requesting a maximum of 6 licences per wildlife management zone. There is no limit as to how many zones you may request licences for.
