The rating system used by the accommodation business must be one recognized by the provincial Department of Tourism, Heritage, and Culture.</p> <p>This letter should:</p> <ul style="list-style-type: none"> <li>• be written by the accommodation business,</li> <li>• include the business name of the accommodation provider and guide service,</li> <li>• state that the rated accommodation provider will host non-resident black bear hunting clients of the guide service for the current year, and</li> <li>• be signed by the owner or manager of the accommodation business.</li> </ul>

- If at a later date you wish to be removed from, or added to, the online list of allocation holders you may do so by notifying the Department of Energy and Resource Development in writing.
